ORDER

This is in continuance of Order No. 3PM(COVID)2020/10056-10105 dated 19.06.2020, 3PM (COVID)/2020/19247-19297 dated 21.08.2020, 3PM (COVID)/2020/19348-19398 dated 28.08.2020, 3PM (COVID)2020/21554-21604 dated 02.10.2020, 3PM (COVID)/2020/26849-26899 dated 07.10.2020, 3PM (COVID)/2020/ 29295-29345 dated 29.10.2020, 3PM (COVID)/2020/30947-31007 dated 12.11.2020, 3PM (COVID)/2020/33749-33809 dated 09.12.2020, 3PM (COVID)/2021/33749-33809 dated 08.01.2021, 3PM (COVID)/2021/610-662 dated 15.01.2021 and 3PM (COVID)/2021/1723- 1775 dated 10.05.2021, 3PM (COVID)2021/3148-3200 dated 04.06.2021 and 3PM (COVID)/2021/3873-3952 dated 15.07.2021; regarding fixation of rates for COVID-19 testing in Haryana State.

2. After due consideration on the matter and advice of experts, taking into account the cost of kits & consumables and studying the precedence in other states, the State Govt., in exercise of the powers bestowed under the Epidemic Diseases Act, 1897, further revises the upper cap of rates for COVID-19 testing as follows:

Table No. 1 for RTPCR testing:

S. No.	RTPCR testing	Maximum Charges per test
1	Samples collected hospitals/labs and collection centres	Rs. 299/- (Already fixed)
2	Samples collected through home visits	Rs. 499/- (Already fixed)

Table No. 2 for other types of COVID testing:

S. No.	Type of COVID-19 Testing	Maximum Charges per test
1	CBNAAT	Rs. 2400/- (Already fixed)
2	TrueNat	Rs. 1250/- (Already fixed)
3	Rapid Antigen testing	Rs. 50/- (from existing Rs. 250/-)
4	IgG based ELISA testing	Rs. 250/- (Already fixed)

3. It is also directed that that **No private laboratory** should charge any amount more than as mentioned in the tables above for COVID-19 testing, inclusive of GST/Taxes (if any), cost involved in pick-up, PPE, packing, transportation of samples, documentation and reporting, in the State of Haryana.

4. It is further directed that all the laboratories conducting COVID-19 testing must adhere to the guidelines and SOPs as mentioned in the previous orders, and shall follow all the testing protocols as laid down by ICMR and MoHFW, Govt. of India from time to time.

These orders are issued with approval of Competent Authority and come into force with immediate effect. Non-adherence to these orders may invoke penalty under section 188 of the Indian Penal Code.
