

HARYANA GOVERNMENT**DEPARTMENT OF HEALTH & FAMILY WELFARE****ORDER**

In continuation to the State Government Order regarding capping of rates for HRCT Chest and other Lab investigations dated 24.05.2021; in order to rationalize the rates of various radiological investigations required for diagnosis/treatment of patients of COVID-19/ post-COVID sequelae and after studying the precedents in neighbouring states, such as Punjab, UT Chandigarh, etc.; the State Government, exercising the powers bestowed under the Epidemic Diseases Act, 1897; limits the maximum charges to be levied for MRI Brain/Orbit/PNS and CT PNS and also revises the maximum charges to be levied for CT/HRCT scan of chest, as tabulated below:

1	MRI Brain (Head)	3000	2200
2	MRI Orbit	2300	1700
3	MRI PNS	4000	2500
4	CT PNS	1800	1000
5	CT/ HRCT Chest	---	1800 (from existing 2100)

These rates are inclusive of all expenses involved in testing i.e. PPE, documentation, reporting, films, GST/Taxes (if any), etc.

These rates are not applicable to the Diagnostic Centres providing services to the Health Department under PPP mode, for which the existing rates (as per MoU) would prevail. However, in no case, the same shall exceed the maximum limit, as mentioned in these orders.

These orders are issued with the approval of Competent Authority and supersede all orders/notifications issued earlier for rates of these investigations by State Government/ Health Department. These rates come into force with immediate effect. Non-adherence to these orders may invoke penalty under section 188 of the Indian Penal Code.


