**Subject: Mode of payment for treatment of COVID-19 patients in COVID Hospitals of Haryana.**

Sir/Madam

I have been directed to invite your attention to the subject mentioned above and Govt. Notification No. 2020/2PM-Pkg(COVID-19)/3567-3766 dated 23.03.2020, regarding fixation of package rates of COVID-19 treatment in Private Medical Colleges and Hospitals of Haryana and to state the mode of payment for treatment of COVID-19 patients at private COVID-19 hospitals. The patients/suspects of COVID-19 are categorised into 4 categories and mode of payment for each of the categories is given below:

**1. Govt. Employees, Pensioners and their dependents-**

The Govt. Employees, Pensioners and their dependents would avail treatment as per the State Government's existing Reimbursement/ Cashless/ Empanelment policies, as the case may be.

**2. Persons having Govt./Private health insurance-**

The Persons having health insurance would avail treatment as per the terms & conditions of the individual policy.

**3. Beneficiaries of Ayushman Bharat (AB) Scheme-**

The beneficiaries of AB scheme would avail treatment on cashless basis, as per the existing AB Scheme.

The COVID hospital shall charge as per the existing AB scheme and submit bills directly to Ayushman Bharat, Haryana.

**4. Persons, which do not come under all the above 3 categories-**

Such persons i.e. Patients/Suspects approaching Govt. Health facilities and then referred to COVID-19 hospitals (Government/Private), which do not fit in all 3 above mentioned categories, would avail treatment on cashless basis.

The COVID-19 hospital shall charge as per the rates of Ayushman Bharat scheme and submit bills against the provided treatment to the concerned Civil

Surgeon (from where the patient has been referred) and private COVID-19 hospitals shall not charge anything from the patients of this category.

The bills submitted by private hospitals would be verified by a committee under chairmanship of Civil Surgeon consisting of Deputy Civil Surgeon (NHM), District Nodal Officer for COVID-19 and Account Officer, as per the package rates approved by State Govt. vide Notification No. 2020/2PM-Pkg(COVID-19)3567-3766 dated 23.03.2020. The payment shall be made to concerned private COVID-19 hospital at district level only.

The funds for making payments to COVID hospitals would be released by O/o NHM Haryana to all the Civil Surgeons of State.

**Subject: Regarding fixation of Package Rates of COVID-19 treatment in Private Medical Colleges and Hospitals of Haryana.**

Sir/Madam

I am directed to invite reference to this office letter No. 2020/2PM-Pkg(COVID-19)/3567-3766 dated 23.03.2020 and No. 2020/2PM-Pkg(COVID-19)/4776-4975 dated 20.04.2020 issued on the subject noted above and to state that this matter has been re-considered and following amendments are done in the point No. 4 of letter No. 2020/2PM-Pkg(COVID-19)/4776-4975 dated 20.04.2020:

**4. Persons, which do not come under all the above 3 categories-**

Such persons i.e. Patients/Suspects approaching Govt. Health facilities and then referred to COVID-19 hospitals (Government/Private), which do not fit in all 3 above mentioned categories, would avail treatment as follows:

- The COVID-19 hospital shall charge as per their existing rates. However, the State Govt. would reimburse the expenditure only as per Ayushman Bharat Scheme rates. The balance amount (Actual bill – AB scheme rates) would be paid by the patient.
- Out of the final medical bill of COVID-19 patient, the bill for charges as per the Ayushman Bharat scheme rates would be submitted to the concerned Civil Surgeon (from where the patient has been referred).
- The bills submitted by private hospitals would be verified by a committee under chairmanship of Civil Surgeon consisting of Deputy Civil Surgeon (NHM), District Nodal Officer for COVID-19 and



Account Officer, as per the package rates approved by State Govt. vide Notification No. 2020/2PM-Pkg(COVID-19)3567-3766 dated 23.03.2020. The payment shall be made to concerned private COVID-19 hospital at district level only.

- The funds for making payments to COVID-19 hospitals would be released by O/o NHM Haryana to all the Civil Surgeons of State.

This issues with the approval of Appropriate Authority.
