ORDER

This is in continuation of Order No. 3PM(COVID)/2020/10056-10105 dated 19.06.2020, 3PM(COVID)/2020/19247-19297 dated 21.08.2020, 3PM(COVID)/2020/19348-19398 dated 28.08.2020, 3PM(COVID)/2020/21554-21604 dated 02.10.2020 and 3PM(COVID)/2020/26849-26899 dated 07.10.2020 regarding fixation of rates for COVID-19 testing in Haryana State.

2. After due consideration on the matter and advice of experts, taking into account the cost of kits & consumables and consent of leading private laboratories, the State Government, in exercise of the powers bestowed under the Epidemic Diseases Act, 1897; directs that **No Private Laboratory** should charge any amount more than as mentioned in the table below for COVID-19 testing, inclusive of GST/Taxes, if any, cost involved in pick-up, PPE, packing, transportation of samples, documentation and reporting, in the State of Haryana:

S. No.	Type of COVID-19 Testing	Rates per test
1.	CBNAAT testing	Rs. 2400/-(Already fixed)
2	TrueNat testing	Rs. 2000/-(Already fixed)
3	IgG based ELISA testing	Rs. 250/- (Already fixed)
4	RTPCR Testing	Rs.900/- (Earlier Rs. 1200/-)
5	Rapid Antigen testing	Rs. 500/- (Earlier Rs. 650/-)

It is further directed that all the laboratories conducting COVID-19 testing must adhere to the guidelines and SOPs as mentioned in the previous orders, and shall follow all the testing protocols as laid down by ICMR and MoHFW, Govt. of India from time to time.

These orders are issued with approval of Competent Authority and come into force with immediate effect. Non-adherence to these orders may invoke penalty under section 188 of the Indian Penal Code.
