Subject: Regarding the Assessment of L2 facilities in the State for COIVD-19.

With reference to the subject cited above ,a D.O letter no D.O N.O.A-21020/16/2020-PH dated 6th May 2020 has been received to conduct real time assessment of L2 Facilities in districts of Haryana designated for the COVID-19.

- 1. As the situation of COVID 19 is evolving in Haryana, the numbers of cases are increasing. Although State has been able to prevent major surge in number of cases. However, considering the high number of COVID-19 cases in neighboring States, it is apprehended that there may be further increase in the number of cases in the State.
- 2. In view of this, State need to strengthen the health infrastructure for prevention & control of COVID-19. In this regard Haryana State has identified three levels of Facilities mainly
  - CCC- COVID-19 Care Centre
  - DCHD- Dedicated COVID Health Center
  - DCH-Dedicated COVID Hospital.
- 3. In this regard, as per the directions from MoHFW, real time assessment of L1 Facilities in districts of Haryana has already been done by NPSP W.H.O. The same report is being shared with you for corrective actions if required any.

4. Furthermore, now in second phase, the assessment of L2 Facilities in districts of Haryana has to be conducted through NPSP-WHO and HSHRC Assessors, Henceforth, you are requested to facilitate the activity with support of District RRT's.

Dear Colleagues,

As you are aware that rapid assessment of dedicated COVID hospitals was conducted during 17<sup>th</sup> to 28<sup>th</sup> April 2020 to ascertain the preparedness of all States/ UTs during the COVID pandemic with technical support from development partners and NHSRC assessors.

The findings were supportive in understanding the ground realities. It was noted that most of the dedicated COVID hospitals have separate entry and exit and separate area for suspect and confirmed cases. The gap in oxygen supported and ventilator supported beds was noted and partners were directed to share the facility wise observation with the States.

Now, it is further proposed to conduct rapid preparedness assessment of Dedicated COVID Health Centers (DCHC) as well, through the technical support of partner organizations (WHO, UNICEF, UNFPA, NIPI and NHSRC). The reports will be shared with the States/UTs by the partners to help you plan and prepare the facilities for treatment of moderate COVID cases.

You are requested to provide necessary support to the teams and facilitate in conducting this assessment.
