Subject: Regarding Referral Transport for COVID-19 cases.

In reference to the subject cited above.

2. In continuation to the letter no. 32/3-IDSP/2020-667-757 Dated: 06.03, letter no 32/3-IDSP-2020-897-905 dt: 12.03.20 and letter no 32/3-IDSP/20/1807-1855 dt:1.4.2020, wherein you were requested to earmark ambulances for transport of suspected cases of COVID-19. Further you were also requested to follow all protocols related to ambulance services like training of Referral transport staff, pre and post sanitization of ambulances etc.,

3. In view of the rising cases of COVID-19 in the State, it is once again reiterated that

- There should be separate Ambulance earmarked for transport of COVID-19 suspected/ confirmed cases and also ensure the availability 24*7 at the district.
- Ensure pre and post sanitization of ambulances as per GoI Guidelines. All the referral transport staff should be trained/sensitized for COVID-19 for all the infection prevention protocol.
- In view of surge of COVID positive cases in the State, kindly explore the possibilities to enroll private/ other ambulances for transportation of Suspected/ positive cases in case of exigency.
- Ensure 24*7 availability of hearse van at the District for COVID-19 deceased persons.

4. You are once again requested to implement the above mentioned directions by ensuring 24*7 ambulance and hearse van services at the districts for COVID-19 cases.
